Risk Mitigation in the Hospitality Industry. Defining risk – real, perceived or tactical – that causes a threat to operations and individuals while ultimately providing safety and security of staff, guests, visitors and the facilities and assets as well as reducing stakeholder liability and expenses to the bottom line.

Vulnerabilities & Threats come from everywhere including Covid, Weather, WiFi access.

Potential countermeasures – what you have in place to mitigate the threats and creating a plan to countermeasure those threats.

Also inside threats – employees that have access to supplies, funds and assets. Access to the building and interior spaces. As well as employee safety when entering guest rooms.

Emergency plans for the property – developed, updated, reviewed. Updated at corporate. Employees to review upon hiring. Staff training beyond new hires.

One of the greatest things you can have is situational awareness and for staff to know to report things even if they're not going to personally deal with it.
