KCHA in 2023 - Open Discussion About Meeting & Speaker Topics

• Meeting attendance and membership participation continue to struggle post covid, due to staffing shortages. There was talk of reducing the number of meeting times per month and it was decided to survey members to find out a) if the day/time of the monthly meeting still works and b) if we should scale back to bi-monthly or quarterly meetings. A survey was sent with 9 responses, mostly saying to keep the date/time of the month and the frequency the same. There has also been a struggle getting nominees for the board. Last year, two new people

were elected and subsequently left the region/industry within a couple months of those appointments. It continues to be an issue again due to staffing shortages and management not having the time to devote to volunteer commitments such as KCHA. A reminder that membership is for a property and there is no limit on the number of people who can attend meetings or requirements on staff positions. Anyone from a property is invited. It was suggested we host some type of networking event to get more people (like a social/happy hour).
